AMAZING WOMEN!



Josephine Baker is often remembered as a trailblazing singer, actress, and dancer of the Jazz Age but few people know that during World War II she supported the Allied cause by working as a spy for the French Resistance. By the start of the war, Baker had already been living in France for many years; she had become a French citizen in 1937 after marrying Jewish Frenchman Jean Lion. Throughout the war, she maintained a busy performance schedule in many of Europe's wartime cities which provided an excellent cover for her covert activities. Baker served as a sub-lieutenant in the Women's Auxiliary of the Free French Air Force and helped spy for the French government by gathering information at high society events held at embassies. Her fame gave her

the unusual ability to visit neutral nations during the war so she assisted the French Resistance by smuggling secrets written in invisible ink on her sheet music. She helped other intelligence agents secure travel visas by including them as part of her performance entourage. Baker also helped many people in danger from the Nazis get visas to leave occupied France. Toward the war's end, she performed for liberated prisoners at Buchenwald who were too weak to move.

For her service to France during the war, Baker was awarded the Croix de guerre and the Medal of the French Resistance with Rosette. She was also made a Chevalier of the Légion d'honneur -- the country's highest decoration -- by General Charles de Gaulle. When Baker passed away in 1975, she became the first American-born woman to receive full French military honors at her funeral. – via A Mighty Girl



Meet Susan La Flesche Picotte, she was the first Native American woman to earn a medical degree in the United States. Born in 1865, Picotte grew up on the Omaha Reservation in Nebraska to mixed parents. As a young girl, she witnessed a local white doctor refuse medical care to a Native American woman, who later died. Picotte credits this instance as inspiration for wanting to become a physician. She left the reservation in 1884 to study at the Hampton Institute in Virginia and graduated in 1886. With the help of a scholarship from the U.S. Office of Indian Affairs, Picotte attended the Women's Medical College of Pennsylvania to earn her medical degree. After finishing her medical internship in 1889, Picotte became the first Native American female physician. She returned to the Omaha reservation to practice medicine, and would go on to overhaul the healthcare that people were receiving there. She was paid very little and was chronically understaffed. However, Picotte worked tirelessly to educate her patients on the importance

of cleanliness and getting rid of trash and flies in order to reduce risk of tuberculosis. Along with being a physician, she was also a champion of Native American causes and lobbied in Washington, DC, in particular against alcohol, which she believed was destroying many Native American communities.

MNWT Foundation

Programs of the Minnesota Women of Today Foundation

Endowment Fund

- Sapphire Club—Contributors make a one-time pledge of \$500 or \$100 paid in installments over a three-year period. Membership is open to individuals, organizations, businesses, and chapters.
- Sustaining Members—contributors who donate \$25 yearly to the overall programs of the Foundation.
- Corporate Solicitations/Grant Seeking Funds are sought from businesses and corporate foundations to support training programs of the MNWT and to supplement donations to the other programs of the Women of Today and its Foundation.
- Outstanding Young Adult Scholarship— Contributions are accepted from individuals, chapters, and
 businesses to provide scholarships for up to five Outstanding Young Adults honored at the Winter State
 Banquet for their volunteer contributions to their communities.
- Outstanding Award Grants—Contributions are accepted from individuals, chapters, and businesses to
 provide a monetary award for the recipient of the Women Who Impact Award. The money is designated
 by the recipient to a charitable organization of their choice.
- Chapter Grants Program—Provides financial grants to MNWT chapters wanting to run that special project they would otherwise be unable to do without financial aid. Applicants must donate \$25 to the Foundation within the past 24 months to be eligible to apply for a grant. Chapter grants are presented annually at the Winter State meeting.

• Member Scholarships

- The Cheryl L. Anderson \$500 scholar ship is presented annually at the Fall State meeting.
 Recipients must be a member of at least two years, be seeking higher education and need financial assistance.
- Straight River scholarships are available up to \$400 for classes relating to people with disabilities. Recipients must be a member of at least two years. Donations are accepted throughout the year from individuals, chapters, and businesses for these scholarships.
